**Nektar is on a mission to create a global governance and philanthropic system owned by the majority of the planet. When at cruising capacity, Nektar could considerably change the way we learn, elect, govern, earn and give back to humanity.**

### Nektar Ecosystem

The Nektar ecosystem consists of the Nektar ID, the Nektar DAO, the Nektar utility token and the Nektar Terminal, a web-base platform that provides access to a range of data, services, apps and marketplaces powered by Nektar for users to learn, promote, track, earn and vote.

### Nektar DAO

The Nektar Initiative is governed by the Nektar DAO. Participating in campaigns, elections and voting on projects is restricted to Nektar DAO members. Holding a Nektar ID (Nektar Governance Token) is the only requirement for membership in the DAO.

### Utility Token

The Nektar token is a multi-purpose voucher, utility\* and reward token native to the Nektar ecosystem. Nektar tokens are issued to all eligible Nektar IDs (where regulations permit) to align their incentives for participating in the Nektar Initiative. Nektar tokens are also necessary to consume our systems and services.

### Principal Approach

Nektar employs a multi-strategy approach by organizing campaigns to capture the will of the people on a large scale and launching projects that support the SDGs.

- DAO members promote, poll and participate in the decision making process of Nektar and the Agency by voting on key decisions. For their participation, they earn tokens which can then be used to access our systems and services.
- The Nektar token powers global high-quality projects that are core to the Nektar ecosystem and that support the SDGs.

### Impact

The Nektar Initiative is an initiative like no other. Our projects are high-impact, led by operators with the skills and history of delivering and designed to reward the community and support youth in 34 countries. DAO members propose, accept or rejects projects and initiatives and they govern Nektar and the Agency who assists nation states adopt bitcoin.
